This is an emergency. Please release my medicine

I hope you all are well.

Please send me my regular supply of medicine. My daily medication requirement is:

- (1) Metoprolol Tartrate, ¼ of 50mg tablet, morning and night, for 1/2 a tablet daily
- (2) Aspirin, 81mg, enteric coated
- (3) Warfarin (Coumadin), 1mg. I take 2 1/2 tablets per day.
- (4) Simvastatin, ½ of 40 mg tablet
- (5) Tamsulosin HCL, 0.4 mg capsule, 2 daily
- (6) Lorazepam, 0.5 mg tablet, as needed
- (a) Would you please send me an account of the medicine sent to me from the Tucson VA after I visited Dr Gibson there on May 12, 2004?
- (b) Who is my primary care provider?
- (c) What was entered into the VA internal computer information system on October 3, 2003, about me, and what is it's significance?

Communicating by email is the only way I known how to minimize confusion, such as that surrounding the three unanswered questions above. I received the following telephone message yesterday, May 11, 2005:

"Mr. O'Connell, this is Julianne French. I'm calling from the Tucson VA Medical Center, and I'm trying to help you get your medications refilled. Will you please call me, in the Chief of Staff's Office? I'm at 520 629 1815. Thank you"

Would you please tell me what you need from me in order for you to release my medicine?

Voice mail from Cottonwood VA, Wednesday, May 18(?), 2005:

"Mr. O'Connell, this is Claudia at the Cottonwood VA Clinic, 649-1523. We received your letter and Dr Collins asked me to call you and let you know what you needed to do. You would have to call eligibility at Prescott, and you would have to an appointment. We can't just take people without an appointment. So you would have to call Prescott, ask to be assigned to the Cottonwood Clinic, and unfortunately we can't guarantee that you would be assigned to Dr. Collins. Assignments are made on a rotating basis, and we don't really have anything to do with assignments. So you would have to call eligibility, ask them to assign you to Cottonwood, once we have received notice that you have been assigned to us we can make you an appointment. So I just wanted to let you know, that's how this would have to go at this point which is the same for any patient that calls us. But if you have any questions, specifically, 649-1523. Thank you, bye, bye"
